Independent Contractor Agreement

This Independent Contractor Agreement (the "Agreement") is entered into by the Northborough Youth Hockey Program, Inc Westborough, Massachusetts, (the "Rink") and
the Independent Contractor, (the "Referee"/"Score Keeper")
WHEREAS, the Rink requires the services of a Referee/Score Keeper to officiate it's hockey games WHEREAS, the Referee/Score Keeper has experience and expertise necessary to provide the aforementioned services to the Rink; WHEREAS, the Referee/Score Keeper wishes to provide the aforementioned services to the Rink. NOW, THEREFORE, in consideration of the mutual promises and agreements contained in this agreement, the Rink and the Referee/Score Keeper, agrees as follows:
 COORDINATION OF SERVICES a. The Rink shall use its best efforts to arrange schedules in a way that minimizes the Referee's/Score Keeper's travel time and other associated costs. The Referee/Score Keeper acknowledges; however, the Rink is dependent on other entities for scheduled ice times and such ice time may NOT be available at convenient times for the Referee/Score Keeper.
2. <u>TERM and TERMINATION</u> The term of this Agreement shall commence on September 1, 2024 and shall continue for period of one (1) year, through and including August 30, 2025 (the "term"). Either the Rink or Referee/Score Keeper may terminate this Agreement prior to its expiration by providing written notice to the other.
3. <u>COMPENSATION</u> The Referee/Score Keeper will be compensated every two weeks. The Rink shall not be liable to the Referee/Score Keeper for any loss of fees resulting from canceled ice time, inclement weather or game changes.
4. INDEPENDENT CONTRACTOR STATUS The parties agree that the Referee/Score Keeper will be an independent contractor for all purposes and that the Referee/Score Keeper will not in any way represent that they are an employee or officer of the Rink. The Referee/Score Keeper is not a partner, joint venturer, or agent of the Rink, nor does the Referee/Score Keeper have any right or authority to incur, assume or create, in writing or otherwise, any warranty, liability, or other obligation of any kind, express or implied, in the name of or on behalf of the Rink.
5. TAXES and BENEFITS The Referee/Score Keeper will not be entitled to participate in or receive any benefit or right as an employee under any employee benefit or welfare plan of the Rink. The Referee/Score Keeper will have sole responsibility for payment of all federal, state, and local taxes or contributions imposed or required under unemployment insurance, social security, and income tax laws and for filing all required tax forms with respect to any amounts paid by the Rink to the Referee/Score Keeper pursuant to this Agreement. The Referee/Score Keeper will indemnify and hold the Rink harmless against any claim or liability (including penalties) resulting from failure of the Referee/Score Keeper to pay such taxes or contributions or file any such tax forms.
6. <u>WARRANTIES</u> The Referee/Score Keeper warrants that their agreement to perform services under this agreement does not violate any other agreement or obligation between the Referee/Score Keeper and a third party.
